LAUMAS ELETTRONICA SRL ensures that the products supplied to its customers comply with the current regulations in regarding the protection of the health of the operators and the environment.

REACH (Registration, Evaluation, Authorisation, Restriction of Chemicals)

In accordance with the REACH regulation 1907/2006/EC, the products manufactured by LAUMAS ELETTRONICA SRL can be classified as articles that do not release, under normal or reasonably foreseeable conditions of use, any substance dangerous to either human health or the environment.

LAUMAS ELETTRONICA SRL declares that it does not intentionally introduce into its manufacturing processes any of the substances identified as "extremely concerning" (SVHC, Substances of Very High Concern) or included in Annex XIV of the REACH Regulation, in a percentage greater than 0.1%. (weight / weight).

The organization also declares, based on its knowledge and the information received from its suppliers, that none of the same substances and limits mentioned above, are contained in the components used and consequently in the products sold.

The list of SVHC substances or "Candidate list" is periodically updated by ECHA (European Chemical Agency) and can be consulted at: <http://echa.europa.eu/it/candidate-list-table>. (last update 06/28/2024)

We will update our customers in the future if substances not currently included in the Annex XIV could be present in our products in quantities greater than 0.1% w/w.

RoHS Directive (Restriction of Hazardous Substances)

In reference to Directive 2011/65/EU (RoHS2) and its update Delegated Dir. 2015/863/EU

(RoHS3) on the restriction of the use of certain dangerous substances in electrical and electronic equipment (RoHS), LAUMAS ELETTRONICA SRL declares that its products comply with the limits established in Annex II, possibly taking advantage of the exemptions listed in Annexes III and IV of this Directive (lead in copper alloys). The substances listed in Annex II with the limits imposed are the following:

- Lead (Pb): < 1000 ppm
- Mercury (Hg): < 1000 ppm
- Cadmium (Cd): < 100 ppm
- Hexavalent chromium (Cr VI) < 1000 ppm
- Polybrominated biphenyls (PBB): < 1000 ppm
- Polybrominated diphenyl ethers (PBDEs): < 1000 ppm
- Bis(2-ethylhexyl) phthalate (DEHP): < 1000 ppm
- Benzybutyl phthalate (BBP): < 1000 ppm
- Dibutyl phthalate (DBP): < 1000 ppm
- Diisobutyl phthalate (DIBP): < 1000 ppm.

Because the REACH regulation and the RoHS directive, with the related lists of substances subject to restrictions, are frequently updated, LAUMAS ELETTRONICA SRL follows their evolution by constantly monitoring any changes.
